Approve Minutes:

October 27, 2016 Commissioner Meeting Minutes approved with suggested changes.

 - Commissioner Leonardo needed pre-approval to pay the Utica National Insurance Group bill up to \$51.00; All in favor, motion carried

- Notice from the Vice President of the Verdoy Fire Association that Paul Bentley was approved by the Association at the meeting on November 14, 2016.
- Notice from Vander Molen that they are raising their prices in 2017 due to increasing costs.
- Notice from the Town of Colonie in regards to public hearing held at the Town of Colonie Zoning Board on November 17, 2016 at 7:00pm.

Notice of intent to become a candidate for the Office of Fire District Commissioner for a five (5) year term from John Marshall and Paul Bentley.

 Received a notice from the Fireman's Association of the State of New York in regards to 2017 FASNY Dues; Advised to hold until January 2017 and add as an organization during 2017 Organizational meeting.

Attorney Hannigan Report:

Presented the letter from PESH in regards to the emergency escape system training.

Report of Chief:

- Officers laptop needs to be replaced; will spec out a new laptop for January 2017 purchase.
- Cost on wireless headsets discussed last month is \$1,066.00 for Truck 11 (state contract price);
 Request to spend up to \$1500 which will include installation. Chairman Leonardo requested to look for company that can both sell and install the headsets. All in favor, APPROVED.
- Received notice in regards to an EMT recertification that was paid out of pocket. Was
 determined through discussion that paperwork just needs to be completed by the Chief for
 member to be reimbursed. Continued discussion on future training needs.
- Attorney Hannigan mentioned that there is a state law that out of county training must be preapproved by the Board of Fire Commissioners. In county training, must be approved by the
 Chief. Out of state training needs to be approved by the Board of Commissioners and a letter
 must be sent to the OFPC stating need and purpose.
- Lengthy discussion on Squad 11
 - Usage ideas are: pump outs, traffic accident usage; rehab purposes; storage of additional cribbing; use as a tender piece. Will go through all compartments and come up with a plan for December as to what will go where.
 - o Further discussion as to whether Squad 11 is the right vehicle for the job.
- Lengthy discussion on Boat 11
 - Priority is finding a location in the water for it; spoke to Chief Cook, County Car 1, and Supervisor Paula Mahan to assist with finding a location.
 - Commissioner Russell is working with the Chiefs; Reading the FAA plan to determine what our role is in support of the Airport.
 - Received two letters in support of the boat program from Supervisor Mahan and County Fire Coordinator, Jerry Paris.
- Commissioner Leonardo mentioned that the Chiefs car (61) is due for inspection in November 2016; possible tire replacement in January 2017.
- Request to install car starter in Car 62. Request approval of up to \$300 to install car starter; All in favor, APPROVED.
