Chief Nick DiNovo and Attorney Greg Serio have been working on compiling data on the volume of in district calls at commercial buildings for business taxes. Discussion regarding past 3 years of commercial calls in district and the timeline of creating a tax zone within the fire district.

CHIEF'S REPORTS:

CHIEF NICK DINOVO:

1. I would like to take a moment and thank each and every member who was available to respond to the fire at the Bangkok Kitchen at 1207 Troy Schenectady Road on 3/17/2025. The incident was originally dispatched as a fire alarm. Upon the arrival of fire crews, they observed a smoke condition coming from the rear of the building. Members forced entry and quickly extinguished a fire within the kitchen. The quick action from our members of forcing entry, stretching a handline, establishing a water supply and

extinguishing the fire allowed the fire to be contained to the area of origin. Excellent job and dedication from all members.

This is now the second fire alarm that has turned into a fire within our district in 2025.

- **2.** The personnel committee has received letters for all three (3) new daytime employees from their Chiefs, allowing them to respond with Verdoy on emergency incidents.
- **3.** Three (3) members Captains Meservey, Giguere and Firefighter Monaghan have signed up for hands on training at the New York City Fire Academy on May 17 & 18. The training consists of Engine and Truck Company Operations. For the training and the hotel, it will cost approximately \$6,000.00.

5. I have a new DX list for outdated equipment. I will have the list for the meeting. *The outdated equipment will be decommissioned (DX'd) out of Verdoy Fire District's inventory.*

6. The Officers and I would like to do some modifications to the decontamination/gear cleaning room. We would like to install a two (2) bay commercial kitchen sink to replace the existing sink. We understand this would involve some plumbing as well as cutting the portion of the countertop. By installing this sink, it will allow us as a department to better decontaminate out turnout gear.

Currently we do not have a location where we are able to clean, soak or sanitize our helmets, masks and boots. This will allow us to do so to maintain the equipment and remove carcinogens.

7. I met with Attorney Serio over the weekend to discuss the RFP and plans for the Mezzanine and bailout simulator. I will have a more detailed report for the meeting.

VERDOY FIRE DISTRICT RESOLUTION NO. 25-30

AUTHORIZING THE WITHDRAWAL OF FUNDS FROM VERDOY FIRE DISTRICT'S CAPITAL RESERVE FUND FOR PAYMENT OF CERTAIN CAPITAL IMPROVEMENTS CORRESPONDING TO THE DISTRICT'S PLAN OF BUILDING REHABILITATION

The Verdoy Fire District Board of Fire Commissioners ("District") at a Meeting held on the 20th day of March, 2025, adopted the following resolution by majority vote:

WHEREAS, the Verdoy Fire District Board of Fire Commissioners ("Board") did establish, pursuant to General Municipal Law §6-g, the "Verdoy Fire District's Capital Reserve Fund," created in accordance with and upon the conditions set forth in General Municipal Law §6-g and for the purposes set forth in the resolution which established such capital reserve fund; and

WHEREAS, after due deliberation, the District has determined that it is in the best interest and in furtherance of its firefighting and other emergency services provided to the citizens of the District to complete certain capital improvements to the fire house located at 988 Troy Schenectady Road, Latham, New York 12110; and

WHEREAS, the District has determined that in order to carry out certain repairs, maintenance and improvements to the firehouse, it will need to withdraw up to \$75,000.00; and

NOW THEREFORE BE IT RESOLVED THAT the District is hereby authorized to expend from the Verdoy Fire District's Capital Reserve Fund an amount not to exceed \$75,000.00 to satisfy the costs for work to be completed consistent with the Plan of Building Rehabilitation; and

IT IS FURTHER RESOLVED that this resolution and its expenditure is subject to a permissive referendum.
